Graduate Council Charge

The Graduate Council of CSU Dominguez Hills serves as a standing committee to the Academic Senate and in an advisory capacity to the Dean of Graduate Studies and Research. Policy considerations and recommendations will be forwarded to both. Graduate student success relies on consultation, inclusion, and the integration of graduate programs into the larger campus. Ensuring graduate student success includes bringing together the faculty, staff, students, and administration involved in the consultative process that encompasses graduate programs which include graduate program design, modification, assessment and evaluation. In addition to providing a network within the campus community for faculty, staff, students and administrators with responsibility for graduate programs, the Council will play an advocacy role for CSU Dominguez Hills graduate programs both on and off campus. Organization of Graduate Council

This was the initial year of the election and meeting of an Executive Board for Graduate Council. The Executive Board is formed of a chair, vice-chair, and a representative from each college. The Executive Board met two weeks prior to each Graduate Council (GC) meeting to discuss new topics or issues from each college that had arisen since the last GC meeting and to develop the agenda for the upcoming GC meeting. Executive Board members serve two year terms.

Topics of Discussion and Actions Taken

Graduate Council discussed a variety of topics during the 2020-2021 academic year. Of primary focus this year has been serving in an advisory capacity to and collaborating with Admissions on new admissions deadlines for graduate programs to begin in Fall 2022, as well as with the Registrar regarding improving existing processes for graduate students and programs.

The council has also consulted with a variety of constituencies on campus, including Admissions and Records, Registrar's Office, Thesis Coordinator, UCC, PRP, and UWC. Guests to Graduate Council meetings, including guest speakers and presenters during the 2020-2021 year have included: Deborah Brandon, John Hill, Ken O'Donnell, Christina Rios, and Maritza Solano.

The items of focus for this past academic year were as follows:

Graduate Level Policies/Processes/Procedures

- Examination of Graduate Coordinator Roles and Responsibilities with initial data collected from program coordinators.

- Consultation with GSR Dean and Thesis Coordinator regarding Thesis submission procedures. The Thesis Submission form has consequently been revised
- Discussed proposing permanent modifications to late drop and admission deferments for graduate students (currently in place due to COVID-19)

Program Curriculum & Modifications

- Reviewed graduate curriculum with consideration to impact to existing programs, and provided the following Impact Statements to UCC:
MA Teaching Spanish, MS Accounting, MA School Leadership, MA Education Curriculum & Instruction, and MS Quality Assurance.
- Discussed and advised on curriculum numbering of doctoral courses for proposed CSUDH doctoral programs.

Admissions and Records Policies/Process/Procedures

- Revisions of Admissions Process and Deadlines
 - GC submitted a formal request to Interim GSR Dean Price to provide permanent option to allow admissions deferral to new graduate student admits (currently pending review by Provost).
 - GC voted in support of Admissions' proposal to change graduate program application deadlines to 4-5 established application and decision deadlines across all graduate programs.
- Revisions to Registration Processes
 - GC submitted formal requests to Registrar's office to improve processes for planned educational leave, petition tracking, add/drops, RD/RP grading, and graduation unit capacity.
- CALSTATE Apply
 - Provision of training by GSR to graduate programs to use 4th quadrant for program application.
 - Discussion of need to establish additional graduate objectives in CSU Apply application (e.g., credential, multiple objectives)

- Continue to develop Graduate Council as a cohesive and collaborative faculty-driven body that is a strong and vocal advocate of graduate programs, students, and faculty.
