Students who obtain a campus e-mail account should be aware that name, student status and e-mail addresses cannot be withheld from Internet access.

How do I select or release FERPA restrictions?

Student may update FERPA restrictions by logging into their myCSUDH account. On the Student Center page, students should navigate to the Personal Information section. Using the drop down dialog box, students may select Privacy Settings to update FERPA restrictions.

Who is protected under FERPA?

FERPA applies to the education records of persons who are, or have been, in attendance in postsecondary institution, including students in cooperative and correspondence study programs and in any non-traditional delivery process, such as distance learning.

What are a student's rights under FERPA?

Under FERPA the student has the right to:

- 1. inspect and review their education records,
- 2. request to amend their education records,
- 3. to limit disclosure of personally identifiable information (information that would directly identify the student or make the student's identity easily traceable) known as directory information,
- 4. file a complaint with the Department of Education concerning an alleged failure by the institution to comply with FERPA.

What is an education record?

Education records are defined as records that are:

- 1. Directly related to a student, and
- 2. Maintained by an educational agency or institutions or a party acting for the agency or institution, if certain conditions are met.

What is not an education record?

Education records are not:

- 1. sole possession records,
- 2. law enforcement unit records,
- 3. employment records,
- 4. medical records, or
- 5. post attendance records.

What is "directory information"?

CSUDH considers the following "Directory Information":

- student's name;
- 2. student's address, including email and postal address;
- telephone listing;
- 4. major field of study;
- 5. participation in officially recognized activities and sports;
- 6. weight and height of members of athletic teams;
- 7. dates of attendance;
- 8. degrees and awards received; and
- 9. the most recent previous educational agency or institution attended by the student.
