Please note: If you were enrolled full-time (12 units) during the Fall and Spring semesters and will enroll at least half-time (6 units) for Summer, you may be eligible to receive additional Pell Grant funds. If you enroll in less than half-time for summer, you will only be considered for remaining Pell Grant eligibility from the 2024-2025 school year (only available if you were enrolled in less than full time during Fall 2024 or Spring 2025).

SECTION 3: Loan

I would like to request a Federal Direct Loan in the amount of \$_____.

Requirement: To be eligible to borrow a Federal Direct Loan, you must be enrolled at least half-time (6 units undergraduate/Teaching Credential/Certificate/2nd Bachelors and 4 units [500 level] graduate). There are two types of loans you may be offered:

- SUBSIDIZED:** The Federal government will pay the interest on your loan while you are enrolled for at least a half-time unit load.
- UNSUBSIDIZED:** The borrower is responsible for the interest accrued on this loan. You may choose to defer the interest while in-school, but the interest will be capitalized (i.e. added to the principal) when you go into repayment.

Note: You will be assessed an origination fee for each disbursement of your loan. These charges do not reduce the amount you are required to repay.

_____ I understand that if my actual summer enrollment does not meet the unit requirement, the loan award will be cancelled and I will be responsible for the payment of my summer tuition fees.
